"Date of Grant" shall mean June 17, 2026.
- Shares held by Andy Corley Living Trust dated 7/17/2013, for which the Reporting Person serves as trustee.
- Shares held by The Corley Foundation (the "Foundation"). The Foundation is a California nonprofit public benefit corporation. The Reporting Person may be deemed to share voting and investment power over the securities held by the Foundation. The Reporting Person disclaims beneficial ownership of such shares except to the extent of his respective pecuniary interests therein.
- Shares held by the Juana McKay Living Trust, for which the Reporting Person's spouse serves as trustee.
